### Notification for Collection of Personal Information

In accordance with the *Personal Information Protection Act* of British Columbia (hereinafter referred to as the “PIPA”), any personal information collected or requested on the Annual Membership Application form or Renewal Application (as the case may be), shall be used by the Rt. Hon. Sir Winston Spencer Churchill Society of British Columbia (hereinafter referred to as the “Society”) only for the purposes of:

- (a) maintaining a list of members of the Society (hereinafter referred to as “Members”) as required by the *Societies Act* of British Columbia;
- (b) maintaining a mail and e-mail distribution list and telephone number list for the purpose communication with Members regarding matters solely related to operation of the Society; including, but limited to (i) the distribution of notices of Society meetings or events of interest to its Members; (ii) the distribution of the magazine “*Finest Hour*”; (iii) the distribution of the e-mail version of “*Chartwell Bulletins*”; and (iv) the raising of contributions for the Sir Winston Spencer Churchill Memorial Fund administered by the Vancouver Foundation (the “Churchill Memorial Fund”); and
- (c) except where otherwise required to be disclosed by law, the information referred to in paragraph (b) above may be distributed to and used by the Society’s Directors, Officers and Administrator to contact Members regarding matters solely related to the operation of the Churchill Society including, but not limited to, (i) the distribution of notices of Society meetings or events of interest to its Members (ii) the distribution of the magazine “*Finest Hour*”; (iii) The distribution of the e-mail version of “*Chartwell Bulletins*”; and (iv) the raising of contributions to the Churchill Memorial Fund.
